6. Regular sources of data	The system compares the personal ID provided with the data in Aspo Plc's shareholder register maintained by Euroclear Finland Ltd, and selects the ownership information of the shareholder registering from the shareholder register.

8. Principles of data security	A. Manual data: The data is stored in locked premises and is available only for eligible persons. B. Electronically stored data: The data is subject to restricted access protected by user ID and password.
